

Affiliate Program T&Cs as at 19th June 2026

1. Referral Qualification

A referral is considered valid when:

- The new member signs up using the affiliate's unique referral link.
 - The new member purchases an eligible annual plan.
 - Payment has been successfully processed.
 - The referred member is not already an existing customer.
 - The referred member is not owned, operated, or controlled by the affiliate.

2. Commission Structure

- 50% Pre-Launch - Plus Listing: \$400mxn
- 50% Pre-Launch - Premium Listing: \$600mxn
- Normal Price - Plus Listing: \$800mxn
- Normal Price - Premium Listing: \$1,200mxn

Vallarta Community Hub reserves the right to change commission rates at any time with 30 days notice to affiliates.

3. Payment Terms

- Commissions are calculated monthly.
 - Payments are made by the 10th day of the following month.
 - Commissions are only paid on completed, non-refunded purchases.
 - Commissions are paid in MXN through Wise.

4. Refunds & Chargebacks

If a referred member receives a refund, initiates a chargeback, or their payment is reversed, Vallarta Community Hub reserves the right to deduct the amount from future commissions.

5. Prohibited Activities

Affiliates may not:

- Hard sell or spam individuals or businesses - this is a referral program only.
- Advertise publicly on Social Media - this is in person, private sharing not selling.
- Use misleading advertising.
- Make false claims about the directory.
- Impersonate Vallarta Community Hub.
- Purchase listings using their own referral link.
- Create fake accounts.
- Offer additional discounts or inclusions.

Any breach may result in removal from the program and forfeiture of unpaid commissions.

6. Referral Tracking

Commissions are tracked using the affiliate's unique Member ID# (you can find this when you create your account).

Vallarta Community Hub cannot guarantee commissions for referrals that cannot be properly tracked.

Our tracking records will be considered final.

7. Affiliate Relationship

Affiliates are independent contractors and are not employees, partners, agents, or representatives of Vallarta Community Hub.

Participation in the program does not create an employment, partnership, or joint venture relationship.

8. Free Premium Listing Benefit

Affiliate Partners with a business they would like listed on the site can set up a complimentary Premium Listing.

To keep this Premium Listing live on the site, 2 referrals on paid plans are required within the first 90 days.

Vallarta Community Hub reserves the right to revoke this benefit if the affiliate account is terminated for breach of these terms.

9. Program Changes

Vallarta Community Hub may modify, suspend, or terminate the Affiliate Program at any time with 30 days notice to the Affiliate Partners.

10. Termination

Either party may terminate participation at any time.

Vallarta Community Hub may immediately terminate participation for fraud, abuse, spam, or violations of these terms.

Unpaid commissions earned before termination will be paid provided all program requirements have been met.

11. Limitation of Liability

Vallarta Community Hub shall not be liable for any indirect, incidental, or consequential losses arising from participation in the Affiliate Program.
